## WEBSITE GDPR PRIVACY NOTICE

### Privacy Statements

Axalta Coating Systems and its affiliates are concerned about privacy issues and want you to be familiar with how we collect, use and disclose information. Together with Axalta Coating Systems Information Policy this Privacy Statement describes Axalta Coating Systems practices in connection with information that we collect through the website or mobile application owned and controlled by Axalta Coating Systems from which you are accessing this Privacy Statement (respectively, the "Site"), as well as offline where notice is legally required. By providing Personal Information to Axalta Coating Systems, you agree to the terms and conditions of this Privacy Statement.

If you apply for a job through the Site, Axalta Coating Systems use of the Personal Information you provide through the Career Center is governed by a separate privacy notice, not this Privacy Statement.

### PERSONAL INFORMATION

Personal Information Axalta Coating Systems Collects

"Personal Information" is information that identifies you as an individual, such as:

- Name;
- Postal address (including billing and shipping addresses);
- Telephone or fax number;
- Email address;
- Credit and debit card number;
- Vendor Tax ID numbers;
- National ID numbers such as Social Security Numbers;
- Financial information when you apply for credit;
- Purchase history.

Axalta Coating Systems collects Personal Information when you participate in various opportunities that we provide, for example:

- When you order a product or service or make a request.
- When you register your purchase of an Axalta Coating Systems product.
- When you submit a warranty card.
- When you register for subscriptions, technology forum or other communications through the Site.
- When you participate in a contest, promotion, sweepstakes, survey or other promotion.
- When you participate in a blog or forum.
- When we conduct market research, meet you at a trade show or other event.

We may combine Personal Information that we collect about you with Personal Information you provide to Axalta Coating Systems through other sources, such as product registrations, inquiries or marketing events. We will use the combined Personal Information in accordance with this Privacy Statement for as long as it is combined.

### How We Use Personal Information

We may use Personal Information for the following purposes:

- Respond to your inquiries and fulfill your requests, such as to send you e-mail alerts.
- Send you important information regarding the Site, changes to Axalta Coating Systems' terms, conditions, and policies and/or other administrative information.
- Complete and fulfill your purchase, for example, to process your payments, have your order delivered to you, communicate with you regarding your purchase and provide you with related customer service.
- Send you marketing communications that we believe may be of interest to you, including information about trade shows.
- Personalize your experience on the Site by presenting products and offers tailored to you.

- Allow you to participate in sweepstakes, contests and similar promotions and to administer these activities. Some of these activities have additional rules, which could contain additional information about how we use and disclose your Personal Information, so we suggest that you read these rules carefully.
- Permit you to send messages to a friend through the Site. By using this functionality, you are telling Axalta Coating Systems that you are entitled to use and provide Axalta Coating Systems with your friend's name and email address.
- Allow you to communicate and interact with others through the Site (for example, through a blog, message board, messaging functionality, chat functionality, profile or other social media).
- Permit you to register and participate in technology forums and other events with Axalta Coating Systems.
- Enable business purposes, such as data analysis, audits, researching and developing new products, enhancing Axalta Coating Systems' website, improving Axalta Coating Systems' services, developing marketing events, identifying usage trends and determining the effectiveness of Axalta Coating Systems' promotional campaigns.
- As we believe to be necessary or appropriate: (a) under applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities including public and government authorities outside your country of residence; (d) to enforce Axalta Coating Systems terms and conditions; (e) to protect Axalta Coating Systems operations; (f) to protect Axalta Coating Systems rights, privacy, safety or property, you or others; and (g) to allow Axalta Coating Systems to pursue available remedies or limit the damages that we may sustain.

## How Personal Information is Disclosed

Your Personal Information may be disclosed:

- Within the Axalta Coating Systems for the purposes described in this Privacy Statement. Axalta Coating Systems and the local affiliate with whom you are interacting are jointly responsible for the management of the jointly-used Personal Information.
- To Axalta Coating Systems' third party service providers who provide services such as website hosting, data analysis, payment processing, order fulfillment, product distribution, infrastructure provision, IT services, customer service, email delivery services, credit card processing, auditing services and other similar services to enable them to provide services.
- To third parties such as agents and distributors to facilitate the sale and distribution of Axalta Coating Systems products and services which may include marketing communications.
- To third parties sponsors of sweepstakes, contests and similar promotions.
- To identify you to anyone to whom you send messages through the Site.
- To a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of Axalta Coating Systems business, assets or stock (including in connection with any bankruptcy or similar proceedings).
- As we believe to be necessary or appropriate: (a) under applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities including public and government authorities outside your country of residence; (d) to enforce Axalta Coating Systems terms and conditions; (e) to protect Axalta Coating Systems operations; (f) to protect Axalta Coating Systems rights, privacy, safety or property, you or others; and (g) to allow Axalta Coating Systems to pursue available remedies or limit the damages that we may sustain.

We are not responsible for any information you choose to submit through these features and we strongly discourage you from disclosing any sensitive Personal Information (such as health or credit card information) through these features. If you use these features, your Personal Information may remain on the Site even after you cease use of the Site.

## NON-PERSONAL INFORMATION

Non-Personal Information We Collect

"Non-Personal Information" is any information that does not reveal your specific identity, such as:

- Browser information;
- Information collected through cookies, pixel tags and other technologies;
- Demographic information and other information provided by you;
- Aggregated information.

## How We Collect Non-Personal Information

Axalta Coating Systems and Axalta Coating Systems' third party service providers may collect Non-Personal Information in a variety of ways, including:

- Through your browser: Certain information is collected by most browsers, such as your Media Access Control (MAC) address, computer name (Windows or Macintosh), screen resolution, operating system version and Internet browser type and version.
- Using cookies: Cookies allow a web server to transfer data to a computer for recordkeeping and other purposes. We use cookies and other technologies to, among other things, better serve you with more tailored information, to facilitate your ongoing access to and use of the Site and to provide you with personalized marketing. If you do not want information collected through the use of cookies, there is a simple procedure in most browsers that allows you to decline the use of cookies. - Using pixel tags, web beacons, clear GIFs or other similar technologies: These may be used in connection with some Site pages and HTML formatted email messages to, among other things, track the actions of Site users and email recipients, measure the success of Axalta Coating Systems marketing campaigns and compile statistics about Site usage and response rates.
- From you: Information such as your location, as well as other information, such as your preferred means of communication, is collected you voluntarily provide this information. Unless combined with Personal Information, this information does not personally identify you or another user of the Site.
- By aggregating information: Aggregated Personal Information does not personally identify you or any other user of the Site, (for example, may use Personal Information to calculate the percentage of Axalta Coating Systems users who have a particular telephone area code).

## How We Use and Disclose Non-Personal Information

Because Non-Personal Information does not personally identify you, we may use and disclose Non-Personal Information for any purpose. In some instances, we may combine Non-Personal Information with Personal Information (such as combining your name with your geographical location). If we combine any Non-Personal Information with Personal Information, e.g., when we combine information you provide upon registration with Non-Personal Information to provide you with targeted personalized marketing, the combined information will be treated by Axalta Coating Systems as Personal Information.

## IP ADDRESSES

Your "IP Address" is a number that is automatically assigned to the computer that you are using by your Internet Service Provider (ISP).

## How We Collect IP Addresses

An IP Address is identified and logged automatically in Axalta Coating Systems server log files whenever a user visits the Site, along with the time of visit and the page(s) that were visited. Collecting IP Addresses is standard practice on the Internet and is done automatically by many web sites.

## How Axalta Coating Systems Uses and Discloses IP Addresses?

Axalta Coating Systems uses IP Addresses for purposes such as calculating Site usage levels, helping diagnose server problems, administering the Site and presenting content that is tailored to your country. We may also use and disclose IP Addresses for all the purposes for which we use and disclose Personal Information. Please note that we treat IP Addresses, server log files and related information as Non-Personal Information, except where we are required to do otherwise under applicable law.

## INTEREST-BASED ADVERTISING

Axalta Coating Systems and Axalta Coating Systems third party service providers use cookies, pixel tags, web beacons, clear GIFs or similar technologies to track the actions of Site users and email recipients across non-affiliate websites over time, in order to personalize your experience on the Site by presenting advertisements that are more relevant to you. ## USE OF SITE BY CHILDREN

Axalta Coating Systems is committed to protecting the privacy needs of children and we encourage parents and guardians to take an active role in children's online activities. Axalta Coating Systems does not target the Site to children less than fourteen (14) years of age or knowingly collect information from children for the purpose of selling products or services. Axalta Coating Systems does participate in select educational programs such as science and environmental awareness in support of schools and communities.

## CROSS-BORDER TRANSFER

### Axalta Coating Systems Global Information Privacy Policy

This policy defines the commitment of Axalta to protect the privacy of personal information that is collected or used by Axalta in the course of conducting Axalta business. The scope of this Policy includes the collection and use of employee, customer, supplier and other third party personal information on a global basis, Axalta will, and will cause its affiliates to, establish and maintain business procedures that are consistent with this policy.

- We respect the privacy rights of individuals. Axalta takes privacy seriously and is committed to complying with all legal requirements regarding the privacy of personal information. Axalta will, from time to time, review its personal information collection, use, and disclosure practices in order to assure compliance with laws and regulations.
- We give notice of Personal Information collection. Axalta will give notice when personal information is collected consistently with applicable law. All notices will explain the need for the information and describe how the information will be used.
- We get explicit consent for sensitive information/opt-in To the extent required by applicable law; Axalta will maintain procedures to assure sensitive information is collected with explicit consent.
- We process and distribute information consistent with notice. Axalta will collect and use personal information consistent with the notices that have been provided. However, Axalta may decide to remove identifiable features from collected personal information and the resulting information may then be used for statistical, historic, scientific or other purposes, consistent with applicable law.
- We provide information security. Axalta will use commercially reasonable efforts to maintain the security of personal information, and protect the integrity of such information.
- We provide individuals a way to access and correct their information. Axalta will maintain commercially reasonable procedures consistent with applicable law for individuals to gain access to their collected personal information and, when appropriate, correct any information that is inaccurate or incomplete, or have their personal information deleted.
- We require others who process Axalta data to comply with applicable law. Axalta will require others who acquire or provide personal information from or to Axalta, including those engaged to provide support services, to appropriately protect personal information.
- We provide a way to process complaints. Axalta will publish the procedures for responding to complaints regarding potential deviations from its established procedures for protecting personal information.
- We will disclose Personal Information when required by Law or court order. Axalta will as permitted or required by law or court order, collect, use, transfer and/or disclose personal information pursuant to procedures that do not require giving notice (for example, in connection with law enforcement investigations).
- We will align our Human Resource processes with the Axalta policy. Axalta will align its Human Resources processes, policies, practices and guidelines to comply with this Policy.
- We retain the flexibility to change this policy. Axalta reserves the right to modify and update this policy or its related business practices at any time.
